


CoC Ranking HMIS Details Guide

The following guide provides information on locating and running the CoC Ranking HMIS Details report within the PA HMIS. This seasonal report is currently available to all users and generates data from HMIS on a per project basis that is used in the most recent CoC Renewal Ranking process for the Balance of State CoC's.

Along with providing aggregated data by Program, this report will also provide a list of all clients enrolled in the program from which the data was pulled.

The CoC Ranking HMIS Details report and is located under the **Home** -> **Case Manager Reports** area of the system. Once in the Case Manager Area, click on the "HUD / HMIS Reports" section shown below and the report will be the 4th one down in the list (circled in red).



Select the CoC Ranking HMIS Details link and the system will load the report filter that will enable you to enter options for which to generate the report.

Date Range: while you can enter in any date range you would like, we highly recommend using the ranking periods for your CoCs. The Eastern CoC for 2019 is using 10/1/2017 – 9/30/2018 and the Western CoC for 2019 is using 1/1/2018 – 12/31/2018.

Continuum of Care (CoC): the report needs to be run on a per CoC basis, and since most agencies serve programs in the same CoC, this should not be a problem. For those that do have programs from multiple CoCs, you can run the report for your programs in each region.

Organization(s): the report will require you to select the organization in which you want to report on and most of the time will automatically select your organization for you (defaults if you have access to only a single organization).

Project(s): the system will require you to select a project or group of projects to be included, which is based both on the organization(s) previously selected as well as the CoC previously selected. For can select a single program at a time or you can combine multiple programs into the same report.

Please note that the report does not filter by “CoC Funding” or “CoC Ranking” projects, it shows all projects under your organization and CoC previously selected. We recommend when looking at this information from a ranking standpoint to only include the projects currently in that process.

Report Format: each included project is included in 2 sections and lists aggregated data for that project and a list of enrolled clients that contributed their data along with whether they were counted or not in each measure.

The highlighted rows show each project and their calculated totals for each criterion used within the CoC Ranking. Underneath each highlighted project row is a section that lists all the client participants of that project that are included/used in the overall calculated totals.

For the client details, each client listed under the project totals, and a 1 denotes "Yes" and a 0 denotes "No" for inclusion (targeted) and/or credit (achieved) for each criterion listed.

Run the Report: Once the report filters have been properly set, simply select the "Report" button on the bottom right-hand side of the screen, this will generate the report.

The report will appear in a new window on your screen, you can use the "PDF Export" option near the top of the report window to create and save the report.
