Dear Eastern PA CoC grantees, members and stakeholders -

This email summarizes the list of projects that have been accepted by the CoC and will be included in the Eastern PA CoC Project Priority List for funding. This includes: renewal projects being submitted at the Annual Renewal Amount shown on the Grant Inventory Worksheet; renewal projects with partial funding reallocated; new project applications received by the CoC; new projects approved and their budgets. Please note that all projects that are being fully or partially reallocated have been informed of the reallocation prior to the distribution of this email.

REALLOCATION

Following the last couple of years of significant reallocation, the Eastern PA CoC will not be reallocating any projects, in part or in full, during the FY2018 CoC Competition.

NEW PROJECTS – BONUS FUNDING

The CoC received 8 new project applications totaling \$934,665. The CoC had a total of \$731,367 in CoC Bonus funding available. The following six projects were approved for funding. This includes:

- Candleheart, PSH, Budget = \$136,661
- Clinton County Housing Coalition, Inc., Northern Tier Rapid Rehousing Project, Budget = \$232,069
- Tableland Services, PSH EXPANSION, Budget = \$64,973
- Tableland Services, RRH DV, Budget = \$102,951
- Valley Youth House Committee, Inc., RRH Expansion Lehigh Valley, Budget = \$85,657
- Veterans Leadership Program of Western Pennsylvania, Inc., PSH for Veterans, Budget = \$109,056

Two new project applications were not approved for funding. This includes:

- Tableland Services, HARP/Operation Hope

NEW PROJECTS – DOMESTIC VIOLENCE (DV) BONUS

In addition to the regular Bonus, the CoC is also eligible to apply for up to \$1,218,944 in funding to expand resources to serve survivors of Domestic Violence. The CoC issued RFPs for a Coordinated Entry Domestic Violence Specialist and Rapid Re-Housing applications from DV organizations to be submitted as sub-recipients under an application to be submitted by the Pennsylvania Coalition on Domestic Violence (PCADV). All applications submitted will be accepted. This includes:

- Transitions of PA, Coordinated Entry DV Specialist, Budget = \$85,668
- Pennsylvania Coalition on Domestic Violence, DV RRH, Budget = \$1,133,276. The the following sub-recipients will be included in this project:

- o Abuse and Rape Crisis Center (Bradford, Sullivan and Tioga Counties);
- o Centre County Women's Resource Center (Centre);
- o Clinton County Women's Center (Clinton);
- o Family Services Incorporated (Blair);

- o Transitions of PA (Columbia, Montour, Northumberland, Snyder, Union);
- o Women's Resource Center (Susquehanna)
