the FY 2018 CoC NOFA Competition.**

Dear Western PA CoC grantees, members and stakeholders -

This email summarizes the list of projects that have been accepted by the CoC and will be included in the Western PA CoC Project Priority List for funding. This includes: renewal projects being submitted at the Annual Renewal Amount shown on the Grant Inventory Worksheet; renewal projects with partial funding reallocated; new project applications received by the CoC; new projects approved and their budgets. Please note that all projects that are being fully or partially reallocated have been informed of the reallocation prior to the distribution of this email.

RENEWAL PROJECTS

The following renewal project has been accepted by the CoC and will be included in the Project Priority Listing submitted to HUD for an amount less than the Annual Renewal Amount indicated on the 2018 Grant Inventory Worksheet (partial reallocation):

- County of Washington, HomeWISE: Annual Renewal Amount from GIW = \$219,006, Voluntarily Reallocating \$30. Renewal Budget = \$218,976.

The following project voluntarily reallocated and will not be submitted for renewal funding:

- Crisis Shelter of Lawrence County, Transitional Housing, Annual Renewal Amount from GIW = \$81,835, fully reallocated budget.

NEW PROJECTS – BONUS/REALLOCATED FUNDING

The CoC received 6 new project applications totaling \$797,880 in funding. The CoC had a total of \$631,505 in funding to award. This amount includes funding from the following sources: \$549,640 through the CoC Bonus, and \$81,865 in reallocated funding. All six projects were approved for funding, with one project's budget reduced due to funding availability. This includes:

- CenClear, CenClear Welcome Home (RRH), Budget = \$110,000 (approved for full budget requested)
- Connect, Westmoreland PSH Expansion, Budget = \$150,707 (approved for full budget requested)
- Fayette County Community Action Agency, Southwest Regional Rapid Re-Housing III, Budget = \$75,602 (approved for full budget requested)
- Lawrence County Social Services, Inc., Coordinated Entry Capacity Funds, Budget = \$62,918. Budget reduced from \$229,293 due to the total amount of funding available.
- McKean Redevelopment and Housing Authority, Northwest RRH, Budget = \$78,894 (approved for full budget requested)
- Veterans Leadership Program of Western PA, Endure (PSH), Budget = \$153,384 (approved for full budget requested)

NEW PROJECTS – DOMESTIC VIOLENCE (DV) BONUS

In addition to the regular Bonus, the CoC is also eligible to apply for up to \$912,126 in funding to expand resources to serve survivors of Domestic Violence. The CoC issued RFPs for DV-dedicated TH/RRH Joint Component projects, Coordinated Entry funding to support DV Assessment Centers and Rapid Re-Housing applications from DV organizations to be submitted as sub-recipients under an application to be submitted by the Pennsylvania Coalition on Domestic Violence (PCADV). All applications submitted will be accepted. This includes:

- Pennsylvania Coalition on Domestic Violence, DV RRH with sub-recipients AWARE, Inc. (Mercer County), Blackburn Center (Westmoreland County), VOICe (Butler County), Budget = \$608,320. Budget reduced from \$623,639 due to the total amount of funding available.
- Crisis Shelter of Lawrence County, TH/RRH Joint Component, Budget = \$207,922 (approved for full budget requested)
- Lawrence County Social Services, Inc., Coordinated Entry DV Assessment Center Funding, Budget = \$95,884 (approved for full budget requested)
