The organization Clarion County Housing Authority (CCHA) opted to voluntarily reallocate this project. CCHA had taken over this grant from another agency via a grant transfer. However, upon beginning to operate the project, CCHA determined that there was not a strong demand for TH resources in their community. As such, they have opted to voluntarily reallocate. CCHA had several conversations with the CoC about this. Formal notification from the CoC regarding this voluntary reallocation was given to the organization on August 8, 2023.
