Things to Remember:

Project applicant was notified of reallocation on 6/20/24. The CoC Funding Committee voted to reallocate this project due to significant, ongoing underspending and underutilization for the past 6 fully completed grant years. The applicant has received monitoring letters from the CoC and technical assistance. Due to underspending, the grant was partially reallocated/reduced in FY21 CoC Competition. The project began operating with the reduced budget on 10/1/22. Even with the reduced budget, the project still continued underspending. As such, the Funding Committee decided to fully reallocate the project.

The CoC Funding Committee voted to reallocate this project due to significant, ongoing underspending and underutilization for the past 3 fully completed grant years. The applicant received a monitoring letter from the CoC Funding Committee in 2023, and the applicant also received technical assistance. However, the Funding Committee did not see improvement and made the decision to fully reallocate the project.

Applicant took over the grant from another recipient via project transfer and opted to voluntarily reallocate the project. This was due to performance of the project and challenges with operations of the project. The project applicant has already been in touch with local housing authorities to identify transition plans for all participants to ensure stable housing as the project winds down (which will be in December 2025).
